# Self-Direction Assessment Final Report in Plain Language

# Self-Direction Assessment Final Report in Plain Language

OPWDD hired a company called Guidehouse to look at the Self-Direction model and give suggestions about how to make improvements.



As part of the review, Guidehouse talked to people who are selfdirecting and to the service providers that support them.

More than 9,000 people who use Self-Direction, their families, Care Coordination Organizations, Fiscal Intermediaries, and Support Brokers talked to Guidehouse about how Self-Direction is working or not working for them.



Guidehouse also looked at articles and research, data and Self-Direction models in other states for new ideas about how to best support people using Self-Direction.

Guidehouse looked at the current model's accessibility, communication, training, quality and sustainability.

# The goals of the review were to:

- Learn how Self-Direction can better support people, especially when they do not have family or friends to help them
- Share how to provide clear and easy to understand information about Self-Direction
- Better understand the needs of children who use Self-Direction
- Improve and clarify the role of Fiscal Intermediaries, Support Brokers and Care Managers
- Support all people who need OPWDD services to learn how to access self-directed services
- Provide a way for people who use Self-Direction and providers who support them to work together and tell OPWDD what they want us to know

- Make the Self-Direction model long-lasting for people who use it and cost effective to implement
- Look at how Self-Direction rules could be changed to support growth of the Self-Direction model

Using the information collected, Guidehouse created a report that shares what they learned about the Self-Direction model, gives 8 recommendations for how OPWDD could make the Self-Direction model better, and provides data and insights from the feedback that was collected.



# **EIGHT RECOMMENDATIONS**

# To Help People Who Use OPWDD Services

## 1. Make Sure All People Who Choose Self-Direction Can Access It:

- डंग
- Learn about who is not able to access Self-Direction, such as where they live and what languages they speak
- Support providers to hire staff who speak more than one language
- Share Self-Direction information with people who do not have access now in the languages and formats they use
- · Make information accessible and available in one easy to access place

## 2. Make Sure People Get Help to Reach Their Goals:

- Give Care Managers responsibility for a person's Circle of Support (A Circle of Support is made up of the people that a person trusts to help them with decisions)
- 2 PS
- Make sure a person's Life Plan includes ways to strengthen their natural supports and Circle of Support
- Identify the people who need a higher level of care planning and who have fewer natural supports (such as family and friends) earlier in the process
- Develop best practices for Support Brokers and Care Managers to support people throughout their lives

### 3. Better Understand Children Who Self-Direct:

 Break up Self-Direction data for children and young adults into two age groups: 0-17 and 18-22 to better understand different service needs between children and young adults




- Explore service options for children and young adults to support the transition out of school
- Partner with the NYS Department of Education and Office of Special Education to share information about OPWDD services
- Consider making changes to the OPWDD Waiver to better match selfdirected services to support children

# To Help Support Staff and Service Providers

## 4. Improve the Quality of Fiscal Intermediary Services:

- · Provide the same expectations for all Fiscal Intermediaries
- Make information for and about Fiscal Intermediaries accessible and available in one easy to access place



- Require more regular reporting by Fiscal Intermediaries
- Develop high standards for which agencies are allowed to provide Fiscal Intermediary services
- Make sure the right number of Fiscal Intermediaries are available and funded to effectively serve people
- Explore Waiver changes to improve the quality of Fiscal Intermediary services





# 5. Improve the Effectiveness of Care Coordination Organizations to Support People Who Self-Direct:

 Meet regularly with Care Coordination Organizations to talk about challenges in Self-Direction, share information and solve common problems



- Better explain the role of the Care Managers for people who self-direct and how it is different than the role of Support Brokers
- Provide Care Managers more education and trainings on Self-Direction
- Create a tool for Care Managers to use with helping people decide if Self-Direction is right for them
- Hold trainings for Care Managers, Support Brokers, and Fiscal Intermediaries to share the best way to work together to support people using Self-Direction

# 6. Strengthen the Ability of Support Brokers to Support People Self-Directing:

- Better explain how the role of Support Brokers is different than the role of Care Managers
- Make the job of a Support Broker more professional
- Work with Fiscal Intermediaries to put standards and monitoring systems in place to make sure Support Brokers are doing their jobs correctly
- Ask Support Brokers who are doing a good job to mentor others
- Develop new and improved trainings and make information available to Support Brokers



# Other Things OPWDD Can Do to Make Self-Direction Work Better

# 7. Make Individual Directed Goods and Services\* easier to understand and access:



- Provide clear and consistent Individual Directed Goods and Services rules
- Standardize how Fiscal Intermediaries approve or deny requests for Individual Directed Goods and Services
- · Provide training and toolkits about Individual Directed Goods and Services
- Collect and track data on Individual Directed Goods and Services

# 8. Use Data to Improve the Outcomes for People Who Self-Direct and Make the Model Cost Effective in the Long Term:

- Track Self-Direction service data and develop dashboards to monitor
- Regularly review overutilization and underutilization of services in the Self-Direction model
- Refine how Self-Direction Personal Resource Accounts (the maximum yearly dollars in a Self-Direction Budget) are projected



 Study service usage to improve value and outcomes for people who self-direct

\* Note: Individual Directed Goods and Services is a Waiver Service available with your Self-Direction budget that helps you take part in community activities, like community classes, and club memberships by paying for eligible costs.






