- Specialty dental care needed for New York Residents
- No dentist in Broome/Tioga Counties or within the Guthrie System
- Wait list is enormous (back to 2021)
- Wait list in Rochester is a year
- Eastern Pennsylvania – not taking new patients

- Karen's son is currently on two wait lists which includes Strong Memorial in Rochester
- Anne Seepersaud gave the following suggestions:
 - Tioga County Dental Van will assist those with special needs.
 - Call ahead and ask for assistance
 - From 12-1pm today Life Plan will be hosting an information seminar for members & families. An attorney will be speaking about how to gain dental care for those facing this challenge. Email link included with the minutes.
 - Legal Aid could possibly help
 - Robert Packer had helped in the past.
