## **Summer Youth Employment Program Information**

The Tioga County Department of Social Services in partnership with Broome-Tioga BOCES is pleased to be offering the Summer Youth Employment Program for 2024. This year the program will run from <u>July 7<sup>TH</sup> – August 7<sup>TH</sup></u> Monday through Thursday is the typical work week with each site having varying hours.

This program builds teamwork, while providing instruction and career exploration with hands-on experience for motivated Tioga County youth, ages 14-20. Supervisors and mentors will provide guidance giving youth the opportunity to obtain beneficial skills and experience. Participants will be paid the current New York State minimum wage of \$15.50 an hour. You are responsible for your own transportation to job sites – we do our best to make job placements as close to your residence as possible. This income is exempt from any assistance you may be receiving at this time.

Eligibility for this program is income based. If your household is in receipt of HEAP, SNAP, Temporary Assistance, Medicaid, or your household income is below 200% of the Federal Poverty Level below you will be income eligible.

between the hours of 4:00 p.m.- 6:00 p.m.

When you arrive, you will need to complete 2 mandatory applications, and you will be interviewed.

If you are under the age of 18, you <u>MUST</u> bring your parent/legal guardian with you, or you cannot apply and will not be seen for an interview.
