- (7) After completing your ballot, insert it into the OFFICIAL BALLOT ENVELOPE provided, seal and sign.
- (8) Return your ballot to the Tioga County Board of Elections by following the instructions printed on the OFFICIAL BALLOT ENVELOPE.
