WHEREAS: After discussing with the Personnel Officer, the Director of Community Services has determined she can better address staffing needs and workload by reclassifying a recently vacated Clinical Social Worker position in order to create a full-time Supervising Clinical Social Worker position; and

WHEREAS: Mental Hygiene has determined that funding for this reclassification is already within its budget; therefore be it

RESOLVED: That effective June 15, 2026, one (1) vacant, full-time Clinical Social Worker position (\$69,259 CSEA SG XVI) shall be reclassified to one (1) full-time Supervising Clinical Social Worker position (\$75,287 CSEA SG XVIII).

WHEREAS: Mental Hygiene has requested through the Personnel Department a promotion for Linda Beers, currently an Accounting Associate III, to be reclassified to a Billing Specialist; and

WHEREAS: Mental Hygiene has determined that funding for this promotion is already within its budget; and

WHEREAS: Mental Hygiene currently has an unfunded Billing Specialist position; and

WHEREAS: The Personnel Officer has determined that the appropriate classification reflective of the work performed and responsibility assigned to Ms. Beers, is consistent with Billing Specialist; therefore be it

RESOLVED: That Linda Beers shall be promoted to Billing Specialist (CSEA SG VIII) \$58,048, effective June 13, 2026, payroll #13; and be it further

RESOLVED: That the Accounting Associate III position being vacated by Ms. Beers be unfunded effective June 13, 2026.

WHEREAS: County Policy requires all contracts that could exceed \$10,000 annually must be approved by the Legislature; and

WHEREAS: Tioga County Mental Hygiene is proactively seeking Legislative approval to enter into agreements with the listed school districts located in Tioga County to provide Mental Health Therapy Services; and

WHEREAS: Tioga County Mental Hygiene will follow all County Policies in regards to the execution of the contracts; therefore be it

RESOLVED: That Tioga County Mental Hygiene is authorized to contract with the following school districts to provide Mental Health Therapy Services for the July 1, 2026, through June 30, 2027, school year:

Newark Valley Central School District
Owego-Apalachin Central School District
Spencer Van-Etten Central School District
Tioga Central School District
Waverly Central School District
